

## PhD re-enrollment (2<sup>nd</sup>, 3<sup>rd</sup> year and more) via ADUM Academic year 2020-2021

**You must re-enroll via ADUM.**

### 1. Your ADUM account's updating

Click on: <http://www.adum.fr/index.pl?site=PSL>

- ☞ Verify and update all your data within the sections and save at each step: sections will turn green:

 Validated
  Ongoing
  To be done

Section "Administrative attachment":

- ☞ You must pay CVEC fees<sup>1</sup> (**92 euros** for the academic year 2020-2021) on <https://cvec.etudiant.gouv.fr/2>
- ☞ Upload your CVEC payment certificate on PDF format. If you are exempted (scholarship, refugee, asylum seeker) you must upload your exemption certificate
- ☞ Save

Section "Status and Funding":

Don't forget to **add** any new funding if concerned.

Section "Thesis progress":

In the event of any change in your PhD progress (supervision, title of your thesis), please download the related form in your private space, complete and sign it.

Section "Individual training contract" (in the event of major changes):

- ☞ Update the form's sections, save
- ☞ In case of major changes, click on "**I submit the Individual training contract (CIF) to my supervisor for correction and advice**"
- ☞ Once it has been approved, download the document, print it, sign it and make it signed by your thesis director, then upload it and **save**. You don't have to upload the document to finalize your re-enrollment, you can upload the final document later.

### 2. Enrollment application

Once all the sections have gone green, click on the last section "**I finalize the procedure**" and then on "**Transmission of the data in order to be validated**". Your thesis director and the doctoral department will check your application.

**When accepted, you will receive an email to ask you to go pay your enrollment fees and upload your re-enrollment file in ADUM.**

<sup>1</sup> The contribution for campus life aims at promoting the welcome, social, health, cultural and sporting support for students and reinforcing the actions of prevention and health education.

<sup>2</sup> The INE number (French equivalent for national student ID) has 11 characters and is required. You can find it on the transcript of your French Baccalaureate (taken in France since 1995) or with the school office of the first French higher education establishment you were registered at. If this year is your first registration at a French higher education establishment you will be attributed a temporary number.

### 3. Enrollment fees payment (section “Tuition fees payment”)

Enrollment fees come to **380 euros** (full-rate) for the academic year 2020-2021 ([decree of April 19<sup>th</sup>, 2019](#)).<sup>3</sup>

**NB:** please use a PC with the following browsers to maximize online payment: Firefox, Chrome  
/\ The payment window will close automatically after your credit card operation. You will receive a payment confirmation by email that you must drag and drop in “Payment method” > “Upload a payment proof in PDF format”.

### 4. File submission

In your ADUM private space:

- ☞ Submit your updated CV (PDF format) and/or photo
- ☞ **For 2<sup>nd</sup> and 3<sup>rd</sup>-year re-enrollments**, click on “**Upload your civil liability certificate 2020-2021 in PDF format**” and submit your file.
- ☞ **For 4<sup>th</sup>-year re-enrollment and more**, click on “**Upload your registration file 2020-2021 in PDF format**” and submit a PDF file including your civil liability insurance certificate and a letter to justify your request for a 4<sup>th</sup> year in PhD (or more), signed by you and your thesis director. **In the event of changes in your PhD progress** please also join the signed form in your PDF file.
- ☞ Save
- ☞ If you have not done it yet, click on “**Upload your Individual training contract (CIF) in PDF format**”, submit your document signed by you and your director of thesis and **save**.

When Service des thèses PSL checks and validates your application and payment you will receive and automatic email to confirm your re-enrollment and will have access to an **enrollment certificate** in your ADUM private space, column “Administrative documents”.

### 5. About the social security

From September 1<sup>st</sup>, 2019 there will no longer be a special student regime and all the students will be under the same general social insurance scheme of the CPAM (French equivalent for public health insurance body) from their residency place.

- ☞ If you were enrolled in a French higher education establishment in 2018-2019;
- ☞ If you have a contract of employment or a doctoral contract (French and international students):
  - ⇒ You will **automatically be attached** to the CPAM without having to take any steps or formalities. You can create a personal account on [ameli.fr](http://ameli.fr).
- ☞ If this is your first registration in a French higher education establishment in 2020-2021 and you don't have any contract of employment nor doctoral contract:

<sup>3</sup> PhD students who benefit from a cotutelle agreement must pay the enrollment fees to the institution determined by their convention.

If those fees are due to the foreign institution, they don't have to pay CVEC fees.

If those fees are due to Université PSL they have to pay the CVEC fees.
